RELEASE, HOLD HARMLESS, AND INDEMNIFICATION AGREEMENT

The undersigned is hereby granted permission to enter what is collectively referred to as the "Property" which includes the premises and properties known as the Marlborough Hunt Club, Incorporated (the "Club") located at 5904 Green Landing Road, Upper Marlboro, Maryland 20772 and/or public land managed by an agency (the "Agency") and the Landowners whose property the Club uses for its activities (the "Landowners") for the events organized by the Club and their or its respective employees, officers, directors, members, agents, guests, landowners, successors and assigns, whether expressed or implied, for the purpose of all equestrian-related events, including but not limited to, fox-hunting, hunt bowl fixtures, horse jumping, steeplechase, relay racing, point-to-point races, games, rallies, lessons, horse exercising, schooling, trial rides and any and all other equestrian related activities ("Activities"). In consideration for such permission and other valuable considerations, the undersigned does hereby remise, release, and forever indemnify, hold harmless and discharge Club, Agency, Landowners, their or its agents, employees, officers, directors, members, guests, and other associated persons and corporations, and their or its respective heirs, personal representatives, successors, and assigns of all above mentioned parties from all claims, suits, actions, causes of action, damages, losses, injuries, medical expenses, loss of services, and demands whatsoever, including any loss, damages to property, personal injuries or death relating to or resulting from the Activities.

I specifically release and hold the Club, Landowners and Agency harmless from any defect or deficiency in the condition of the Property. I know the risks and dangers associated with the Activities, and know that unanticipated and unexpected dangers may arise during the Activities. I recognize that the Activities are high risk and inherently dangerous. I assume all risks of injury to persons and property that may be sustained in connection with any Activities on the Property.

I hereby represent and certify that my true age is eighteen (18) years of age or older. I further represent and certify that the foregoing Release, Hold Harmless, and Indemnification Agreement has been read before being signed, that the contents thereof are known and understood, and that the Indemnifying Release was signed voluntarily and without any undue influence from anyone whomsoever. This Release, Hold Harmless, and Indemnification Agreement may continue from year to year hereafter, and unless and until cancelled and withdrawn in writing, at any time, by the Club, Agency, Landowner or the undersigned, their or its agents, successors, and assigns.
